**Vendor Rules and Regulations**

Vendor Hours: 9am to 4pm– Main Street.

Set Up Times: Friday July 12<sup>th</sup>, after 7pm and Saturday July 13<sup>th</sup> from 7:00 am to 8:45am.

VENDORS MUST BE SET UP BY 9:00 AM

*This event is an outdoor event, held on Main Street Unadilla. This event will NOT have a rain date.*

1. The full rental price of the space requested shall be paid by July 1, 2019. Any space requested after June 10th will require an additional \$10 late fee for each space, from the vendor, paid up front. **No booth space shall be assigned until payment in full is received.**
2. If you pay for a 10x10 space, you may not expand to a larger space without proper payment for the next 10x10 space.
3. The Event will be held rain or Shine. The rental fee is for space only. **THERE ARE NO REFUNDS** of any sort for ANY reason.
4. You **MUST** provide your own tables, chairs and shelters.
5. **All vendors must provide their own electricity, via Generator or batteries.** (All applicants must provide a list of items, that will be exchanged for money at the day of sale. In the effort to bolster sales, vendors with duplicate items may not be accepted. (permits will be granted on a first come basis)
6. All vendors selling any food item must meet all Otsego County and NYS Health Regulations and **must provide a copy of the food vendor permit with this application.** This is mandatory!
7. Items allowable: food, crafts, wholesale, novelties, retail items, antiques, collectibles and artworks.
8. **Items NOT allowed:** Firearms, Knives, Explosives, Alcohol, Drugs or Paraphernalia and Any printed or copied works infringing on copyright or anything that is deemed illegal by the State of New York and the USA.
9. All Vendors must be set up and open for business by 9am, Saturday, July 14<sup>th</sup>, 2018.
10. Vendors not set up and in operation will be declared forfeit and the space filled at the discretion of the Event Chairperson.
11. Vendors will have designated parking...No long term parking on Main Street.
12. Vendor's exhibits must be within the rented area. No items, tables or chairs are allowed outside the defined rented area.
13. Shelters allowed: tarps with stakes, canopies, E-Z ups or sun tents may be used within your pace. When taking down Shelters do it with care of the public in mind.
14. You may set up your tent on Friday night July 13<sup>th</sup> after 7pm. There is **NO** overnight security provided.
15. Liability of Vendors: In no case shall the Unadilla Chamber of Commerce, the Event Chairperson or the Village of Unadilla be held responsible for any loss, damage, injury, theft, death, or any other unforeseen occurrence at the Unadilla Carnival of Sales, set up, day of sale or tear down.
16. The Event Committee has the right to interpret the above rules and to determine all matters pertinent thereto, and also the payments, contracts and participation rights by the vendor. There are NO refunds due to inclement weather, civil unrest or acts of God.
17. Vendors are responsible for their own monetary collections and also the collection and payment of any and all applicable sales taxes to New York State.

Every Vendor is responsible for clean-up of the rented space. **NOTHING IS TO BE LEFT BEHIND. TAKE EVERYTHING WITH YOU! THIS INCLUDES ANY AND ALL GARBAGE.**

Port-a-johns will be available within a reasonable and accessible area from vendor area.
